## **Proud Boy Supporter Jumps Curb Driving through Sidewalk where Black Lives Matter Protestors Were Setting Up**

On Saturday, October 3, 2020 at approximately 1:40 pm, a white male South Pasadena resident, Richard Cheney drove his Ram 1800 truck across opposing traffic and onto the sidewalk on the southwest corner of Fair Oaks and Mission. His dangerous maneuver crossed three lanes of opposing traffic, with his vehicle coming to rest, just short of a foot away from the metal barrier in front of Starbucks, nearly hitting Black Lives Matter protestors. Fortunately, the protestors and nearby pedestrians were not hurt. Cheney was also heard yelling from his open window, "So, you're gonna keep putting those signs up?" Police were called by several witness. The watch commander who never came to the scene and the supervisor on duty who arrived after witnesses were interviewed, both came to the conclusion that they would not arrest or cite Cheney without providing any logical explanation or report number. Despite eyewitness accounts and videos documenting what happened, no arrests were made, and no citations were given. The South Pasadena Police Department has since issued a statement on October 3, 2020 that "[t]he case will be presented to the District Attorney for filing considerations." No police report has been made available as of 10/15/20.

Concerned residents and community members of South Pasadena condemn this violent and dangerous act. There has been repeated inaction and lack of accountability of the South Pasadena Police Department to protect and serve the community, particularly for marginalized community members that include Black and Latinx residents. During a time when protestors rightfully exercise their First Amendment right to free speech and peaceful assembly to support Black lives, across the country we have witnessed horrible incidents of counter-protestors who retaliate by driving their vehicles through crowds to intentionally harm Black Lives Matter supporters. What happened on the afternoon of October 3, echoes the intent of these egregious acts, and what is not acceptable is that there were no consequences whatsoever for Richard Cheney, before he was escorted to his vehicle to leave.

More importantly, the incident involving Richard Cheney is by no means an isolated incident and may have been premeditated based on social media posts made regarding protest signs at this location. Fahren James, one of the founders of the Black Lives Matter movement in South Pasadena, has already been assaulted while protesting at Fair Oaks and Mission. This past July, Joe Richcreek, a career criminal who has been arrested over 30 times and prosecuted 20 times, yelled and spat on her and on the face of another protestor while holding a rock in one hand and a double-sided sharpened drummer's stick under his arm. On August 30, 2020, Zane

Crumley, a Black Lives Matter protestor was attacked by Michael Plough, a 41 year-old white male resident of South Pasadena, and his wife Jane Mi, a 42 year-old female Asian resident of South Pasadena on the 110 block of El Centro Street. The couple accused Crumley of disturbing the peace while he played music in support of the Black Lives Matter movement, and they assaulted him, breaking his laptop and his tooth. We believe that Fahren James and Black Lives Matter protestors have become a target for local vigilantes and is an example of how systemic racism has impeded justice. We are deeply concerned for the safety of Fahren James and Black Lives Matter protestors and support their right to peaceful protest, as this now marks the fourth incident. It is absolutely crucial that community members are not endangered and have their right to free speech protected.

On December 21, 2016, South Pasadena adopted Resolution 7491, a resolution of the City Council of the city of South Pasadena, California, affirming the city of South Pasadena's commitment to diversity and to safeguarding the civil rights, safety and dignity of all of our residents. South Pasadena community members want to see a real demonstration to exercise this resolution now and an investigation of Police Chief Ortiz and police practices in the department.

## **TIMELINE OF EVENTS**

### **INVOLVING BLM PROTESTORS AND THE SOUTH PASADENA POLICE DEPARTMENT**

#### **(1) June 1, 2020**

**First protest for Black lives is held at the intersection of Fair Oaks and Mission.**

#### **(2) June 26, 2020**

**Nails are found in the driveways of several homes that display Black Lives Matter signs.**

The extent of city and police investigation into these incidents is unknown.

#### **(3) July 4, 2020**

**BLM and South Pasadena Youth for Police Reform hold a community-wide march for justice for Black lives lost to police brutality.**

#### **(4) July 8, 2020**

**After a white male spits on two BLM protestors, SPPD arrests the suspect and provides inaccurate descriptions of the incident in police reports, characterizing Fahren James as participating in “anti police protest” in the city.**

Joe Richcreek, a white male, spits on two BLM protestors, including Fahren James, founder of BLM South Pasadena, at the intersection of Fair Oaks and Mission. Prior to this assault, Richcreek was observed viewing a protest sign that read: “I don’t know who needs this, but police aren’t supposed to kill guilty people either.”

Police arrive to arrest Richcreek. They find a rock in his pocket. Neither officers at the scene of arrest take down any information regarding the assault before heading toward their vehicles to leave. One of the two BLM protestors, Victoria, calls out to the officers who then walk back and begin collecting the victims’ statements.

#### **(5) July 10, 2020**

**Joe Richcreek returns to the BLM protest intersection on Fair Oaks and Mission and throws a rock at Fahren James, BLM organizer.**

Two days after spitting at BLM protestors, Joe Richcreek returns to the intersection of Fair Oaks and Mission. He calls Fahren James a “fucking bitch” and throws a fist-sized rock at her. Richcreek is stopped by another woman.

SPPD officers arrive and do not arrest Richcreek. The officers request Ms. James to make a citizen's arrest instead.

Following the citizen's arrest, one officer expresses to London Lang, founder of South Pasadena Youth for Police Reform and brother of Ms. James: "The cop hating around here is so wrong brother. . . . Because we aren't Minneapolis. This is South Pas, bro. We don't do that to people."

Mr. Lang tells the officer why they are protesting in South Pasadena: "It's just real life situations. . . . Black people, once you guys see them, you guys put them in handcuffs."

In the arrest report, signed July 11, 2020 by Corporal Randy Wise, the following statement appears as part of the officer's account of the incident: "James has been participating in an ongoing, daily, anti police protest at the intersection." This is false. Ms. James has consistently made it clear that the protest is about justice, equality, and fairness for Black people in policing; the protest is not anti-police.

SPPD does not investigate the July 8 and July 10 incidents as hate crimes and does not refer hate crime charges to the District Attorney. A District Attorney deputy contacts Ms. James and informs her the District Attorney will consider hate crime charges even though the incident was not investigated as a hate crime by SPPD.

#### **(6) July 24, 2020**

**Chief Ortiz makes a public statement to the *South Pasadena Review* that SPPD has removed all mention of blue lives matter and the thin blue line from police property, including uniforms, equipment, and their Facebook page.**

Blue lives matter and the thin blue line have become synonymous with white supremacist groups, primarily as a counter-movement to BLM.

#### **(7) August 30, 2020**

**South Pasadena couple attacks BLM protestor who is walking down a street with a sound system, knocking out his tooth and damaging his laptop.**

Michael Plough, a white male, and Jane Mi, an Asian American female, attacks Zane, a BLM protestor, during the anniversary March for Vanessa Marquez. Ms. Marquez was fatally shot by SPPD in 2018 during a welfare check. Officers fired 12 rounds at Ms. Marquez, and the District Attorney's office declined to press criminal charges. Zane speaks through a microphone that the march is going on, that Ms. Marquez was shot two years ago, and that people should come out and support. He also plays music through speakers.

Prior to the attack, Mi approached Zane and asked him to stop. Zane responded that when people stop killing people, they would stop protesting.

SPPD arrives and Plough and Mi falsely inform officers that they attacked Zane because he hit their baby. Eye witnesses provide their account and video footage of the assault to dispute Plough and Mi's allegations. The police arrest Plough. According to the SPPD public statement on this incident, "Plough was taken into custody for battery" and referred to the District Attorney "for consideration of charges against Mi of attempt [sic] grand theft person and vandalism." No hate crimes were considered or charged.

#### **(8) September 24 – 26, 2020**

**SPPD Chief Joe Ortiz emails an invitation to a prayer event to be hosted by the anti-Black, and anti-LGBT group, American Society for the Defense of Tradition, Family, and Property.**

One day after the announcement of the failed indictments of the officers who shot Breonna Taylor and increasing public demonstrations nationwide, Chief Ortiz promotes a prayer event held by the American Society for the Defense of Tradition, Family, and Property, a hate group that pushes anti-Black views as its counter-movement to BLM. In his email, Chief Ortiz, describes the event as "an excellent opportunity to meet with some of our community members who want to show their support and publicly recognize all first responders and the excellent work that we do." Later that evening, Chief Ortiz rescinds the invitation by email, informs city officials that the event "has been postponed until further notice," and issues a written apology.

Over 500 South Pasadena and other residents sign a petition, organized by Care First South Pasadena, calling for an investigation into Chief Ortiz and SPPD's ties to the hate group. Twenty-two organizations sign a similar letter. Both are shared with the City Council prior to their October 7 meeting, and both are submitted as public comment for the meeting. Many individuals also call into the meeting to provide public comment by telephone.

The City Council does not discuss the incident at all during the October 7 meeting. Rather, the Interim City Manager merely mentions Chief Ortiz had apologized. There is no discussion about an investigation or acknowledgment of the community's call for action.

#### **(9) October 3, 2020**

**Richard Cheney, a white male, barrels into Fahren James and other BLM protestors at the corner of Fair Oaks and Mission with a pick-up truck, and is allowed to leave without even a traffic citation by SPPD officers.**

Richard Cheney, a white male, jumps the curb, barreling through the sidewalk where Fahren James and other protestors are setting up. Cheney nearly hits three people. He yells out of his car, "So you're going to keep putting those signs up anyway." Cheney then states he is going to call the Police Chief and proceeds to make a call. He says, "She's still putting these signs up. I'm here on the corner right now."

When the first officer arrives, Cheney pulls back off the sidewalk, going in the opposite direction of traffic and makes an illegal left turn. Cheney tells officers he was on the sidewalk because he was looking for parking at Starbucks, located at the corner.

Seven witnesses provide statements to the police.

SPPD releases Cheney with no citations or arrests. An officer shares she is instructed to release Cheney without a citation or arrest under the direction of the Watch Commander and the Police Chief.

It remains unclear from SPPD's media release of this incident what charges are being pursued or investigated.

The Anti-Racism Committee of South Pasadena issues a statement calling for an investigation of this incident as a hate crime, pursuant to the department's own policy manual, and for the City Council to directly condemn white supremacist activities that threaten the safety of residents, among other demands.

On Friday, July 10, 2020, at approximately [8:20 p.m.](#), South Pasadena Police Officers responded to the area of Fremont Avenue and Lyndon Street for a reported battery suspect being detained. When officers arrived, they learned the suspect was the same suspect from the previous July 8<sup>th</sup> spitting incident at Fair Oaks Avenue and Mission Street. In that incident, the suspect engaged in a verbal argument with the victim and spit on her.

It was determined the victim, a "Black Lives Matter" protestor, was at Fair Oaks Avenue and Mission Street when she saw the suspect riding his bicycle nearby. The victim recognized and followed him to the area of Fremont Avenue and Lyndon Street. At this point the suspect threw a rock, striking the victim in the leg. The victim and several witnesses were able to corner the suspect preventing him from leaving until officers arrived.

The suspect, identified as 56-year-old Joe Richcreek of Los Angeles, was arrested without incident. The case will be presented to the Los Angeles County District Attorney for filing.

#### Arrest Made in Attack on Protester

SOUTH PASADENA, CA – On Sunday, August 30, 2020 at approximately 12:00 p.m., Michael Plough, 41, a resident of South Pasadena called the police department to complain about a lone protester in the 1100 block of El Centro Street disturbing the peace by playing loud music. Less than four minutes later, Plough and his wife, Jane Mi, 42, (who was holding their juvenile child at the time), confronted the protester. According to the victim, Mi attempted to steal the protester's laptop from him. Plough then attacked the protester, believing the protester hit their child.

Several witnesses called the police department and provided video showing that the protester did not fight back, and that Plough and Mi were the dominant aggressors in the incident. Plough was taken into custody for battery and later booked at the Alhambra Police Department, and later released on a citation with a future court date. Mi was released at the scene due to a lack of an alternate caregiver for their child. The case will be referred to the Alhambra Office of the District Attorney for consideration of charges against Mi of attempt grand theft person and vandalism.

The protester that sustained minor injuries from the altercation and was treated by paramedics at the scene but declined transportation to a medical facility. The protester was adamant that he was part of his own protest and was not part of the "Vanessa Marquez 2nd Anniversary & Community March" occurring concurrently in a different area of the city.

**Protest Incident-Update**  
**Incident Date: October 3, 2020**

SOUTH PASADENA, CA – On Saturday afternoon, a female adult placed political signs on the traffic signals located on the southwest corner of Fair Oaks Avenue and Mission Street. A motorist illegally drove his truck onto the handicap ramp to get the female's attention. He then assertively expressed to the woman his opposition of her attempt to post political signs on public property. The woman contacted the South Pasadena Police Department for assistance, expressing that she believed the motorist's action was an attack against her. Officers quickly arrived on the scene, de-escalated the situation, and interviewed the reporting party, the motorist, and witnesses at the scene.

The driver reported to the officers on scene that he did not attempt to strike the protestor, but admitted to driving his truck onto the sidewalk to express his objections to the woman's attempt to post the political signs in the public right away. The incident is the subject of an ongoing investigation. When the investigation is completed, the findings will be forwarded to the Los Angeles County District Attorney's Office for review and potential criminal filing.

Some community members have asked why the driver was not issued a traffic citation for driving and parking on the sidewalk. In such incidents, all violations, including traffic violations, will be examined in their totality.
